Sir Vivian Ramsey



Sir Vivian Ramsey qualified as a civil engineer before studying law, being called to the Bar in 1979 and becoming a QC in 1992. He practised as a barrister in Keating Chambers and was Head of Chambers. He established an international practice as an advocate, arbitrator, adjudicator and mediator in technical and commercial disputes.

In November 2005 he was appointed as a High Court Judge and served as judge in charge of the Technology and Construction Court in London. In 2011 he retired and now acts as a judge, arbitrator, mediator, dispute board member and expert. He also lectures widely and edits Keating on Construction Contracts. In January 2015 was appointed as an International Judge in the new Singapore International Commercial Court.
